

# Personal Data Protection

## Privacy Notice for Website Visitors

Under the Personal Data Protection Law No. 6698 ("Law"), PROF. DR. BÜLENT DİNÇ (hereinafter referred to as the "Doctor") is defined as the data controller due to the processing of your personal data. Pursuant to Article 10 of the Law, titled "Obligation to Inform," data controllers are obliged to inform data subjects on certain matters regarding the processing of their personal data.

This text has been prepared by the Doctor both to ensure compliance with the legislation and to act in a transparent and accountable manner.

**Data Subject:** You, as the person who visits our clinic's website and whose personal data we process for this reason, are defined as the data subject under the Law.

**Data Controller:** The Doctor, who determines the purposes and means of processing personal data relating to you and is responsible for establishing and managing the data recording system, is the data controller.

Your personal data is processed by us for the purposes set out above.

## **To Whom and For What Purpose Your Personal Data May Be Transferred**

Your personal data may be transferred to the relevant authorities, without an obligation to inform and without seeking your explicit consent, upon request within the scope of KVKK Art. 28/1.

In addition, in unforeseeable situations, your personal data may be transferred to public institutions specified in the laws (such as administrative authorities like ministries) upon request in cases explicitly stated in the laws, within the purposes and limitations set forth in the legislation.

Except for our legal obligations that do not require an obligation to inform and do not require your explicit consent, your personal data is not transferred.

## **Methods of Collection of Personal Data**

Your personal data is collected through your visit to our website by automated means.

## **Your Rights Regarding Your Personal Data**

Data subjects must first submit their requests regarding their personal data to the data controller. Pursuant to the Law, you may exercise the following rights with respect to your personal data:

- a) To learn whether your personal data is processed;
- b) If your personal data has been processed, to request information regarding such processing;
- c) To learn the purpose of processing your personal data and whether it is used in accordance with that purpose;
- ç) To know the third parties to whom your personal data is transferred domestically or abroad;
- d) To request correction of your personal data if it is processed incompletely or inaccurately;
- e) To request deletion or destruction of your personal data if the reasons requiring processing cease to exist;
- f) To request notification of the actions taken pursuant to items (d) and (e) to third parties to whom your personal data has been transferred;
- g) To object to an outcome against you arising from analysis of your processed data exclusively through automated systems;
- ğ) To request compensation for damages if you suffer damages due to unlawful processing of your personal data.

## **Application Method**

You may submit your application:

Your application should include:

- Your name and surname, and if the application is in writing, your signature;
- For citizens of the Republic of Türkiye, your Turkish ID number; if you are a foreign national, your nationality, passport number or, if any, your ID number;
- Your residential or workplace address for service;
- If any, your electronic mail address for notification, telephone and fax number;
- Your request subject.

The Doctor reserves the right to verify your identity.

You may find procedural rules to be followed during application and more detailed information in the Personal Data Protection Authority's Communiqué on the Procedures and Principles of Application to the Data Controller.
